Terms & Conditions

- 1. The closing date for entries is **13 December 2017**.
- 2. The Lichfield & Tamworth Chamber of Commerce charity of the year is open to all charities regardless of whether they are a member of the Greater Birmingham Chambers of Commerce, but must be within the geographical area that the Greater Birmingham Chambers of Commerce covers. If you are the successful chosen charity, then as an additional benefit, you would be encouraged to become a member of the Greater Birmingham Chambers of Commerce which covers the areas of; Birmingham, Burton, Chase, Lichfield, Tamworth, Sutton & Solihull
- **3.** Entries must be electronic and in one single document in either Microsoft Word or pdf format and in English.
- 4. All questions must be answered in the appropriate text box. Text boxes can be expanded if necessary.
- **5.** The maximum file size for any entry is 2MB. If your entry exceeds this file size it automatically will be disqualified.
- 6. Supporting information should be included within the entry form using the appropriate text boxes. Please be aware that any website links used within your entry will not be activated or viewed by the President.
- 7. All entries will be acknowledged on receipt. All entries will be treated in confidence and entry forms will become the property of Greater Birmingham Chambers of Commerce. Entries will not be returned.
- 8. Applicants must be authorised to enter their charity into the process.
- **9.** The President's decision is final and no correspondence will be entered into.
- **10.** The President reserves the right to audit any information supplied.
- **11.** Greater Birmingham Chambers of Commerce reserves the right to withdraw any applicant supplying false information within their entry.
- **12.** The chosen charity will be announced at the end of the evening on 9 January 2018 after voting has taken place.
- **13.** All shortlisted charities and the chosen charity will be publicised.
- **14.** By registering and completing an application form, you agree to these terms and conditions.

<u>Judging</u>

All entries received by the deadline will be judged by the President and Vice President of Lichfield & Tamworth Chamber of Commerce & Industry and a final shortlist of four charities will be drawn up.

Each shortlisted charity will present at the event on 9 January 2018 where the winner will be announced after Chamber members on the evening have voted.
